The undersigned Declarant, representing more than 67% of the combined voting power of the Owner Member and Declarant Member classes of the River Bluff Ranch Association, and pursuant to the provisions for Amendment of Declaration in Section 9.4 of that certain Declaration Establishing Covenants, Conditions, Restrictions, Reservations, and Easements of River Bluff Ranch recorded February 6, 2002 under Auditor's File No. 4686883,

hereby amends said Declaration as follows:

Sub-Section 3.4.2 is deleted in its entirety and replaced as follows:

" 3.4.2 Declarant Membership - Declarant Membership shall be that held by Declarant (or its successors-in-interest) who shall be entitled to three (3) votes for each Lot owned by Declarant plus three (3) votes for each ten (10) acres of unplatted land that is: 1) owned by Declarant, 2) reserved for future development, and 3) has been annexed into the Project. Declarant Membership shall be converted to Owner Membership, with resulting reduction of voting power from three to one vote per Lot owned, when annexation pursuant to 2.4.1.1 has ceased and the total outstanding votes held by Owner Members exceeds the total outstanding votes held by the Declarant Members."

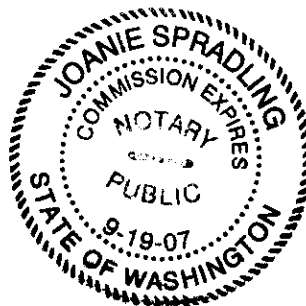
